- -The district has a new AI committee.
- -Senate Bill 29 was discussed and how it protects student data.
- -Dr. Stafford addressed the importance of training; especially around identifying information of students.
- -Megan is going to take the two policies to the AI committee as the Academic Committee agrees that both policies have good content. A Google doc will be created.
- -The district is going to implement the red, yellow, green light model. (use AI vs. do not use it depending on the assignment)

- -Kirstie broke down the number of students in the elementary who are below grade level on reading.
- -Intervention is more intentional by focusing on the students' actual reading deficiency.
- -10-12 groups per grade level are currently being pulled.
- -During the small group time, gifted students are being pulled as well.
- -All other students are involved in centers, BOOST, and there are chapter book studies.
- -mClass pulls the student data from DIBELS scores to appropriately group students for intervention.
- -Kirstie gave an overview of HMH (math) and CKLA (ELA).
- -mClass check up was shared: this is a tool for observing a lesson and providing feedback in a positive, non-evaluative manner.
- -There was conversation about parent education around math and how/why it is taught the way it is in today's educational system.
