## Motion 038-17 Approve Superintendent Recommendations

## Personnel

A. Three year contract for *Jeff Langdon* as Director of Operations-Human Resources effective August 1, 2017 through July 31, 2020 per attached.

## Instructional

- B. After school training on new math series for K-12 Math teachers and Intervention Specialists. Teachers will be paid \$25.00 per hour, not to exceed two hours.
- C. Professional development workshops/training between June 5<sup>th</sup> and June 30<sup>th</sup> for teachers grades K-6 at \$75.00 for half-day or \$150.00 for full day; not to exceed 2 days of training per teacher. Stipends paid from Title 1 funds.
- D. Professional development workshops/trainings between June 5<sup>th</sup> and June 30<sup>th</sup> for teachers grades 7-12 at \$75.00 for half-day or \$150.00 for full day; not to exceed 2 days of training per teacher.
- E. Summer tutoring and test administration for Third Grade ELA test. Teachers will provide 10 hours of tutoring and will administer both the OST and MAP assessments (5 hours) at \$25.00 per hour not to exceed 15 hours.
- F. Summer School June 12 June 30 for grades 8-12 for the purpose of credit recovery for credit bearing courses. Summer school proctor compensated at \$25.00 per hour for a maximum of 40 hours.
- G. Lisa Voss to grade online Health courses June 5 August 11 at \$25.00 per hour; not to exceed 5 hours.



H. Summer Tutoring and test administration for high school EOC exams in ELA 1, ELA II, Algebra I, Geometry,

Biology, U.S. History and U.S. Government. Each teacher will offer

2 hours of tutoring prior to test administration at \$25.00 per hour for a maximum of 6 hours per course
