

Meal Charge Policy

Charges for meals or milk are permitted for students who occasionally forget or misplace their money. We ask that charges be repaid the following school day. Students who do not repay charges on the following school day will be allowed a <u>MAXIMUM</u> of 3 charges. Only a regular complete lunch or milk can be charged, no ala carte' items. Cafeteria cashiers will give a notification slip. Any student that has accumulated 3 charges and is sent to school without money or packed lunch will receive an **Alternate Meal** that meets the minimum nutritional requirement.

Parents/ guardians may use the online payment system or deposit cash or check into the student's account directly with a cafeteria cashier. Students who qualify for free or reduced meals shall never be denied a reimbursable meal even if they have accrued a negative balance from previous purchases. Students with outstanding meal charge debt will be allowed to purchase a meal if the student pays for the meal when it is received. Negative balances will be carried over to the following school year. These balances could affect certain student privileges if not paid.
